**Residential Rates**

Applicable to all single-phase farm and home consumers, schools, churches and community halls supplied through a single meter subject to the Cooperative's Rules and Regulations as they exist or may be amended from time to time.

**RURAL DOMESTIC SERVICE:**

**MONTHLY RATE:**

Customer Charge:	\$25.00 per month
Demand Charge:	\$5.00 per kW of billing demand
Energy Charge:	8.573 cents per kWh for all Summer Use 7.973 cents per kWh for all non-Summer Use

**ELECTRIC HEAT RATE (OPTIONAL) :**

Applicable to Consumers that have permanently installed electric heat as the primary source of heating for the premises. The consumer must notify the Cooperative prior to the winter season if electing to take service under the optional rate. The optional rate applies only for the billing months of December, January, February and March. **The Rural Domestic Service rates will be in place for all other billing months.**

**MONTHLY RATE:**

Customer Charge	\$25.00/month
Demand Charge:	
First 8 kW	\$5.00 per kW of billing demand
Excess kW	\$1.00 per kW of billing demand
Energy Charge:	7.973 cents per kWh for all non-Summer Use

SINGLE-PHASE EARTH-COUPLED HEAT PUMP SERVICE EXPERIMENTAL

This rate is applicable to single-phase services of a single character, where the Consumer permanently installs and uses an earth-coupled heat pump as the major source of heating and cooling of the residence. For this rate to be effective, the Consumer must inform the Cooperative in writing of the equipment installation and receive approval by the Cooperative for the installation. The Cooperative may require a visual inspection of the installation prior to its approval. Individual electric motor sizes are limited to 10 hp and smaller.

MONTHLY RATE:

Summer Season

Demand Charge	\$5.00 per kW of billing demand
Energy Charge	8.573 cents per kWh

Non-summer Season

Demand Charge	\$5.00 per kW of billing demand

PREPAY SERVICE:

MONTHLY RATE:

Customer Charge:	\$30.00 per month
Energy Charge:	11.839 cents per kWh for all Summer Use 11.239 cents per kWh for all non-Summer Use

SEASONS:

The Summer season shall be the billing months of June, July, August and September. The non-Summer season shall be the billing months of October through May.

**DETERMINATION OF BILLING DEMAND:**

The billing demand shall be the highest demand measured during the peak period, which shall be between 3:00 p.m. and 9:00 p.m. Additionally, during the months of September through June, the billing demand shall not be less than 70% of the highest billing demand established during the preceding months of July and August.

*Note that currently, weekends and the following holidays are excluded from the determination of billing demand.*

**ENERGY COST ADJUSTMENT**

The rates for energy to which this adjustment is applicable shall be increased or decreased by 0.001¢ per kilowatt hour (kWh) for each 0.001¢ (or major fraction thereof) increase or decrease in the aggregate cost of energy per kWh as computed by the following formula.

**MINIMUM CHARGE:**

The minimum monthly charge shall be the applicable customer charge plus \$0.75/kVA of installed transformer capacity in excess of 15 kVA, or that as called for in the Cooperative's Rules and Regulations. No energy is included for the customer charge portion of the minimum.

**TERMS OF PAYMENT:**

The above rates and minimum are net, the gross rates being five (5%) percent higher. In the event the current monthly bill is not paid twenty (20) days after date of bill, gross rates shall apply.
