GENERAL SERVICE LARGE

APPLICABILITY:

Applicable to commercial, industrial and other consumers where the transformer kVA is not less than 300 kVA. Rate is subject to the Cooperative's Rules and Regulations as they exist or may be amended from time to time.

TYPE AND CHARACTER OF SERVICE:

Single or three-phase, 60 hertz, at available voltages.

MONTHLY RATE:

Customer Charge \$150.00 per month

Demand Charge: \$15.00 per kilowatt of Billing Demand

Energy Charge: 5.179 cents per kWh

Plus all applicable adjustments, surcharges and riders.

POWER COST ADJUSTMENT:

The above rates shall be increased or decreased in accordance with Schedule PCA as it currently exists or may be amended from time to time.

PROPERTY TAX ADJUSTMENT:

The above rates shall be increased or decreased in accordance with Schedule PTA as it currently exists or may be amended from time to time.

DETERMINATION OF BILLING DEMAND:

The maximum kilowatt demand established by the Consumer for any period of fifteen consecutive minutes during the month for which the bill is rendered, as indicated or recorded by a demand meter and adjusted for power factor as provided hereafter.

MINIMUM CHARGE:

The minimum demand and energy monthly charge shall be the highest of the following:

1. \$2.00 per installed kVA of transformer capacity; or
2. The minimum monthly charge specified in the service contract.

POWER FACTOR ADJUSTMENT:

The Consumer agrees to maintain unity power factor as nearly as practicable. Demand charges will be adjusted to correct for average power factors lower than 90%. Such adjustments will be made by increasing the measured demand one (1%) percent for each percent that the average power factor is less than 90% lagging.

CONDITIONS OF SERVICE:

1. Service under this schedule is limited to transformer kVA not less than 300 kVA. Service is accepted under this schedule for a period of not less than one year, unless consumer's transformer kVa changes thereby requiring reclassification to another schedule.
2. Both power and lighting shall be billed at the foregoing rate. If a separate meter is required for the lighting circuit, the registration of the two watt-hour meters shall be added to obtain total kilowatt hours used and the registration of the two demand meters shall be added to obtain the total kilowatt demand.
3. If service is furnished at secondary voltage, the delivery point shall be the metering point unless otherwise specified in the contract for service. All wiring, poles, and appurtenances on the load side of the delivery point shall be owned and maintained by the Consumer.

- 4. If service is furnished at the Cooperative's primary line voltage, the delivery point shall be the point of attachment of Cooperative's primary line to consumer's transformer structure unless otherwise specified in the contract for service. All wiring, poles and appurtenances (except measuring equipment) on the load side of the delivery point shall be owned and maintained by the Consumer.
- 5. If service is furnished at primary voltage with the Consumer owning the substation equipment, a discount of three (3%) percent shall apply to the total demand and energy charges as determined by the rates set forth in this schedule.

TERMS OF PAYMENT:

The above rates and minimum are net, the gross rates being five (5%) percent higher. In the event the current monthly bill is not paid twenty (20) days after date of bill, gross rates shall apply.
